1. Sixpence:

Student/Caseload update-It is a new school year so there is a little turnover. Some are moving to the next program. We are working to fill the spots based on priority grid and parent need.

Waiting List Update Data Systems Update Current Data:

- A. Attendance-School attendance does require ongoing encouragement
- b. Number of home visits-above 85%
- c. How many parents are attending parenting group?

We just held a socialization last night—six attended. We now have a facebook page for communication/networking. Privacy is guarded within a secret group. We don't interact with them on the faceboook site however, it does open up

another avenue of communication. Katie Donahoo, the intervention specialist at the high school can also be of assistance.

- **f. Any attrition?** We had one move to North Dakota and 3 transitioned to Head Start.

2. Community Cafes

Verna Haberman is interested in using the Community Cafes for elementary level. Amy has plenty of supplies to pass on to Verna.

3. Circle of Security

We had an H3C meeting last week where discussion was that we could really see the value of the classes. Roxanne said it is a parenting class of 8 sessions. They are 1-2 hours each session. It is \$160 per attendee. It is cost prohibitive for many. Maybe through this relationship we could sponsor some classes. Joni said we could help out next year. The outcomes for bonding have been very successful. Noelle said Karla from Family Care offer the class for free and the only cost would be materials. We would need to find space to hold meetings. There could be scholarships available for some classes. Dr. Hall is promoting this in Nebraska. Roxanne will touch base with him about coming to Grand Island. Diann mentioned there are some people in Grand Island who would be willing to help with funding as well. Joni mentioned some dollars will open up after the first of the year within the H3C funds.
